#### **CAMPAIGNING SUCCESS - THANK YOU!**

Thank you to all those who supported AvMA's campaign and who signed the petition calling for the dropping of controversial plans by the Ministry of Justice to rob 25% of the general damages awarded to babies brain damaged through clinical negligence in Legal Aid cases. IT WORKED! We are glad to inform you this outrageous plan has now been dropped!

#### AVMA SUBMISSIONS RE SAFETY IN THE NEW SYSTEM

AvMA has made submissions to two recent consultations by the Department of Health, calling for important changes or additions to the plans for the reformed NHS in England. #### NO "APOLOGIES BILL" WITHOUT A "DUTY OF CANDOUR"

AvMA has responded to a Scottish consultation on a proposed "Apologies Bill" which would spell out that apologies are not an admission of liability and make certain apologies inadmissible in court. Whilst welcoming the intentions, AvMA point out that such a provision could have unintended consequences and should not go ahead without a corresponding "Duty of Candour" with patients/relatives when things go wrong. #### BETTER REGULATION OF COSMETIC TREATMENTS

AvMA has submitted evidence to the Department of Health review of the regulation of cosmetic treatments. AvMA is calling for statutory regulation of treatments like Botox, dermal fillers, and laser treatments. AvMA has also made proposals for an indemnity guarantee for patients harmed by any regulated health treatment or implants/devices and an independent service to help with private sector complaints. #### HOSPITAL SERVICES STRETCHED TO THE LIMIT

A new report by the Royal College of Physicians 'Hospitals on the Edge?' paints a worrying picture of under resourced hospitals struggling to cope with rising demand. Elderly patients are facing the consequences more than any other group. The report comes just weeks before the publication of the report of the public inquiry about Mid Staffordshire NHS Foundation Trust. It adds weight to AvMA's conviction that almost 'perfect storm' conditions for further 'Staffords' have been created by a mixture of financial cut backs, massive re-organisation and fragmentation of the NHS, and low morale.

#### DATA ON 'NEVER EVENTS' PUBLISHED

The Department of Health has finally published updated data on the reported incidences of so-called 'Never events', having initially refused AvMA's application under the Freedom of Information Act. 'Never events' are a list of 25 things that go wrong and cause harm which should never happen in a well-run NHS which follows existing guidance. Examples include misplaced naso-gastric tubes or surgery on the wrong part of the body or wrong patient. The number of reported incidents has more than doubled from 2010-11 to 2011-12. #### LIVERPOOL CARE PATHWAY

Pressure is mounting for an independent review of the Liverpool Care Pathway (the NHS guidelines on end of life care) and legal measures to ensure it is not abused. There is mounting evidence that the LCP is not being followed as it should; patients/relatives are not being involved in decisions and in some cases hydration stopped or powerful opioid drops used inappropriately. Ann Reeves, a veteran of the campaign around the Gosport War Memorial Hospital scandal and since, has launched a petition. Click <a href="here">here</a> to add your support.
