I have read the reports, copies of which are enclosed/attached from which it is apparent that failures in the care provided to my **[STATE RELATIONSHIP EG BROTHER]** contributed to his/her death.

I take this opportunity to draw to your attention the factors that I believe amount to a failure of care:

It does appear that these failures in care at the very least give rise to a reasonable suspicion that their death was unnatural' and as such there are grounds to open an inquest.


